In pursuance of the approval of the competent authority of the Karbi Anglong Autonomous Council, Diphu, vide No. KAAC/EH &-&/Prio/Approval/2024/16, dated 06/11/2024 and No. KAAC/CSB-32/SPP approval/1/2023-24/1954, dated 27/12/2023, 30/05/2025 and No. KAAC/EH&SPP/approval/1/2023-24/1955, dated 30/07/2025, applications in Standard Form from Indian citizens having a permanent resident of successfully completed the prescribed training (course of One Year VFA Training Course in Elementary Knowledge of Animal Husbandry & Veterinary Science) are the School of Veterinary Science & Animal Husbandry, Ghunguri, Silchar, for filling up the following 49 (Forty-nine) vacant posts of Veterinary Field Assistant (VFA) under the Animal Husbandry & Veterinary Department, Karbi Anglong Autonomous Council, subject to fulfillment of all prescribed conditions and availability of sanctioned vacancies.

The recruitment shall be governed by the provisions of the Assam Animal Husbandry & Veterinary Subordinate Service Rules, 2002, as amended from time to time, and other rules/orders applicable to the service.

The number of posts indicated above shall be subject to availability of sanctioned vacant posts and approval of the competent authority.

- a. were selected by the Central Selection Board, KAAC, for undergoing the One Year VFA Training Course pursuant to Advertisement No. KAAC/CSB-30/VPF/JF/CSB/2024-25/503, dated 20th December/2024 and Advertisement No. KAAC/CSB-30/VFLP/CSB/2024-25/10, dated 14th May/2025 and Prior Approval No. KADC/Policy Approval/Ur/202324/1954, dated 30/07/2025.
- b. have successfully completed the prescribed One Year Training Course in Elementary Knowledge of Animal Husbandry & Veterinary Science from the recognised School of Veterinary Science & Animal Husbandry, Ghunguri, Silchar.
- c. fulfill all other conditions prescribed under the Assam Animal Husbandry & Veterinary Subordinate Service Rules, 2002, as amended from time to time, and applicable rules/orders.

- a. passed the HSSLC (Science) Examination with Biology as a subject from a recognised Board/Council; and
- b. successfully completed the prescribed One Year Training Course in Elementary Knowledge of Animal Husbandry & Veterinary Science from the recognised School of Veterinary Science & Animal Husbandry, Ghunguri, Silchar.
- c. The qualification shall be as prescribed under the applicable provisions of the Assam Animal Husbandry & Veterinary Subordinate Service Rules, 2002, as amended from time to time.

4. **Age:** The age of the candidates shall be governed by the applicable provisions of the Assam Animal Husbandry & Veterinary Subordinate Service Rules, 2002, and Government orders/instructions in force from time to time. The age of the candidate shall be determined on the basis of the HSLC Certificate / HSLC Admit Card or certificate issued by the recognised Board/Council. No other document shall ordinarily be accepted as proof of age.

5. Physical Fitness: A candidate for direct recruitment to the cadre of Veterinary Field Assistant must be of sound health, both mentally and physically, and free from any organic defect or bodily infirmity likely to interfere with the efficient performance of his/her duties. The selected candidate shall be required to undergo medical examination before appointment to the service.

6. Selection Procedure: The selection of candidates shall be made by the Central Selection Board on the basis of merit, subject to fulfillment of all prescribed eligibility conditions, availability of sanctioned vacant posts and observance of the applicable reservation policy. Since the candidates covered under this advertisement have already been selected by the Central Selection Board for undergoing the prescribed One Year VFA Training Course and have successfully completed the said training, no fresh written examination shall be conducted.

Method of Assessment –

- i. **HSSLC (Science) Examination – 20 Marks:** Twenty percent (20%) of the percentage of marks obtained by the candidate in the HSSLC (Science) Examination shall be taken into consideration.
 - ii. **One Year VFA Training Course – 40 Marks:** Forty percent (40%) of the percentage of marks obtained by the candidate in the prescribed One Year VFA Training Course in Elementary Knowledge of Animal Husbandry & Veterinary Science shall be taken into consideration.
 - iii. **Viva-Voce – 40 Marks:** The eligible candidates shall appear before the Central Selection Board/Interview Board for Viva-Voce carrying 40 (Forty) marks. The Viva-Voce may assess the candidate's knowledge of basic Animal Husbandry & Veterinary Science, practical understanding acquired during the training course, general awareness, personality for the post and other matters considered relevant by the Selection Board.
- The marks obtained under A, B and C above shall be added together to arrive at the candidate's total score out of 100 marks.

- HSSLC Certificate/Admit Card and Mark Sheet.
- One Year VFA Training Course Certificate issued by the School of Veterinary Science & Animal Husbandry, Ghunguri, Silchar.
- Permanent Resident Certificate (PRC)/Domicile Certificate, as applicable.
- Caste Certificate (if applicable), issued by the competent authority.
- Certificate of registration with Employment Exchange.
- Declaration in Form-IX under the Assam Public Services (Application of Small Families Norms in Direct Recruitment) Rules, 2019.
- Any other relevant documents as may be required by the Central Selection Board.

- The candidates must indicate KAAC, Diphu (Karbi Anglong) as their Choice while filling up their candidature and PRC (Diphu) / Deputy-ship for collecting the Certificate Verification from the respective office.
- The candidates must attach a self-addressed stamped envelope of size 23 cm x 10 cm along with the application form.
- No Bank Draft/Money Order/Cash/Cheque shall be accepted towards payment of any fee.
- The applicants must furnish self-attested copies of all certificates, mark sheets and testimonials demanded by the office.
